SYNOPSIS:

The Professional Practice Committee (PPC) of the Board of Engineers Malaysia (BEM) is conducting its second online session for Melaka-based Practising Engineers to further deliberate on numerous ground issues encountered when dealing with local authorities and utility agencies.

This session aims to further deliberate on the technical disputes identified in Melaka by local practicing engineers. The focused discussions will serve as a constructive platform to examine the issues in detail and to formulate practical solutions in support of the pilot project's objectives with the Malaysia Productivity Corporation (MPC).

As background, this initiative follows the Sesi Perbincangan Berkaitan Penubuhan Online Tribunal for Technical Disputes in Construction Permits, held on 16 April 2025 at MPC Kuala Lumpur. During that session, MPC and the Ministry of Local Government Development (KPKT) proposed the establishment of an online tribunal to facilitate faster resolution of interpretation disputes.

An engagement session with IEM Melaka to compile examples of relevant technical issues, which will subsequently be submitted to the consultant through MPC and KPKT for the trial run
